CITY OF MT. PULASKI BANDSTAND/GAZEBO PRIVATE USE POLICIES AND AGREEMENT

The Mt. Pulaski Gazebo is available for private use for special events as well as approved public events

The Gazebo and surrounding area shall be under the supervision of the Mayor and/or his/her appointed Substitute. The following **Policies** set forth by the Mt. Pulaski City Council are as follows:

- 1) Gazebo used only for the private special event or public event as requested.
- City Ordinances pertaining to controlled substances, intoxicants, and disorderly conduct will Be strictly enforced. NO ALCOHOL ALLOWED.
- 3) Decorating permissible; however, the use of nails, staples, glue, or thumbtacks is prohibited.
- 4) No rice, birdseed, or items that leave debris on the property are allowed.
- 5) No garbage, trash, or debris should be left inside, around or on the grounds surrounding the gazebo after the event is over.
- 6) The city does not provide help in setting up or taking down before or after your event.
- 7) The city does not provide chairs or seating for the event. You must provide yourself.
- 8) The city does not provide greenery or flowers for your event. You may bring potted plants or flowers or use the removable flowerpots to the left and right of the stairs of the gazebo. But they must be replaced after the event.
- 9) The gazebo is supplied with electricity and lights, but prior notice is necessary for their use.
- 10) You **MUST REMOVE** all decorations and trash following your event. There are trash receptacles all around the Courthouse grounds.
- FEE: All private users will pay a User Deposit of \$25.00. You will be asked to pay <u>prior</u> to your event and it will be refunded to you if all the policies are complied with during and after your event is over.

<u>Non-Resident Fee: \$25.00</u> – If you are not a resident of Mt. Pulaski there is a \$25.00 fee Mt. Pulaski Residents will not be charged for use.

<u>Non-Resident Fee</u>: \$25.00 User Deposit and Use Fee \$25.00 = \$50.00 <u>Mt. Pulaski Residents</u>: \$25.00 User Deposit and No Use Fee = \$25.00 <u>Public events and organization use</u>: No fee, however, request for use is necessary so as not to conflict with already scheduled events.
